### GDPR

Since the introduction of the General Data Protection Regulation (GDPR), consent has to be more explicit and transparent so at the point of data collection, the individual will need to be informed exactly how their data will be used and who it will be shared with. Please refer to the school GDPR and Privacy Notice for more detailed information. This is available from the school office and on the website.

Due to GDPR, we need to obtain your consent for certain activities we carry out in school. These help to enhance your child's education, promote well-being and keep you informed. This consent will be for the whole time that your child will be attending the school. Please note that you can withdraw consent at any time by contacting the school office.

#### Email and text service

We would like to use the email and mobile number that we have on record, so that we can continue to communicate with you using our text and email service. For safeguarding reasons, phone calls and letters will always be used to communicate safeguarding, well-being and personal messages relating to your child. However, we may also contact you with information, but not restricted to, school based activities and information for example updates, activities in the school community and other activities that may be of benefit to you or your child.

#### Photography and video

We regularly take photographs of children in our school. We use these images to enhance the children's education and make them feel good about themselves. We use them as part of our school displays, environment, and children's books and sometimes in printed publications. We also use them on our school website, twitter and our school based social media activities. From time to time, images may be used by media organisations such as news and films crews, newspapers and appear on their associated social media, who may use the images to publicise the schools work.

If we use photographs and videos of individual pupils, we will not use the name of the pupil in the accompanying text or photo caption.

If we name a pupil, we will not use a photograph of that child to accompany the article, without parental consent which we will seek before publishing it e.g. if a child wins an award etc. Videos of plays and productions may be taken for internal use.

**Local visits**
